Notice inviting Tender for the supply of hydraulic **JCB** Backhoe line (i.e., crane for mowing and digging), on hire basis, for cleaning of wild growth/ bushes and grass cutting, at our hostel zone.

Subject job has to be carried out at our Hostel Zone, consisting of 20 hostels.

The bidders are advised to quote for hiring of their JCB, **on hourly basis**. The rate quoted per hour should be all inclusive rate i.e., **hire charges for the JCB + salary of the JCB operator**.

For moving the garbage, unskilled labourers will be provided by us, at our cost.

Date and time of taking up and completion of the Job will be decided mutually by the successful bidder and by the Hostel Office.

Last date of submission of tender: 26<sup>th</sup> September 2012 3 p.m

Date of opening of tender: 26<sup>th</sup> September 2012 3.30 p.m at our stores office at administration building

The envelope should be addressed to the **Chief Warden, Hostel, National Institute of Technology, Tiruchy-15**. The top right hand corner of the envelope will have clear superscription in bold letters "**Hiring of JCB backhoe line for grass cutting and clearing of wild growth at hostel zone of NITT**". The Chief Warden, NITT reserves the right to reject any or all the Tenders without assigning any reason therefore.

Adequate safety precaution should be taken by the contractor to avoid any accident while carrying out the job. The contractor shall take every practicable precaution not to damage or injure any adjoining or other properties

or any person. He shall indemnify and keep indemnified the employees against all claims and injuries or damages to any person or any such property (whatsoever including surface of other damage to land or crops on the side) which may arise out of or in consequence of any negligence or default on the part of the contractor or his agents, servants or representatives and against all claims, demands in respect of or in relation thereto.

Unilateral stoppage of work: The contractor shall not stop the work in case of any dispute unless the nature of dispute is such that further progress of work has been rendered impossible. Unilateral stoppage of work by the contractor shall be considered as breach of contract and the NITT Hostel Office reserves the right to take such action as it may deemed fit keeping its interest paramount .In the event of the contractor failing to fulfil the obligations under the contract, NITT Hostel Office has a right to get the work done at the contractors risk and cost reserving its right for damage.

Hostel office, NITT reserves the right to terminate the contract at any time before the expiry of the contract period without assigning any reason to the contractor for which no compensation will be paid.

**Payment will be made on successful completion and certification by the wardens of the respective hostels.**
