Scope of the Work

Vendor Installation and Configuration Requirement

After delivery of the server, the vendor must perform the following installation and setup activities at NIT Trichy:

Operating System Installation

1. Install Proxmox VE (Virtual Environment) – Free Edition (latest stable release) as the primary virtualization platform.
2. Ensure all required drivers, repositories, and web management interface are configured and accessible.

Storage Configuration

1. Configure the two NVMe SSDs in RAID 1 mode for the Proxmox VE operating system installation and boot.
2. Data Storage (SAS HDDs):
 1. Configure 7 × 2.4 TB SAS HDDs in RAID 10 mode using 6 drives for the RAID array and 1 drive as a global hot spare.
 2. Create the RAID volume using the hardware RAID controller and verify the array health after initialization.

Virtual Machine Creation

1. Create two virtual machine (VM) using Ubuntu Server (latest LTS version) and Windows OS (OS will be provided by us) as the guest operating system.
