Installation , maintenance and user Training is required during the entire 1st year. Hence a a resident Engineer should be employed and posted at NIT, Trichy for the 1st year .

SECTION VI-A : QUALIFICATION CRITERIA

- 1 (a) The bidder should have set up 5 virtual class rooms and integrated them in at least one institution in any one of the last 3 years. The equipments offered for supply must be of the most recent series models incorporating the latest improvements in design. Further, bidder should be in continuous business of manufacturing products similar to that specified in the schedule of requirements during the last three years prior to bid opening.
2. The bidder should furnish the information of each of past three years supplies and satisfactory performance for both (a) and (b) above, in proforma under Section XI. The bidders are required to enclose the present status and performance report from the institutions in which the VCRs are set up.
- 3 (vi) Total financial turnover of at least Rs. 300.00 lakhs over a period of last three years excluding current financial year.
- (vii) A demo of the proposed VC system should be given between 23rd – 25th SEP 2013 on prior email intimation to adrc@nitt.edu.
The demo should include
 - (1) 15 clients out of which at least one is from NIT, Trichy
 - (2) Should demonstrate and record different modes teaching : Chalk and talk, Document Sharing, Presentations and Animations
 - (3) demo results including both audio and video should be recorded and submitted in CD form to NIT, Trichy at the conclusion of the demo session.
- viii. Schematic description of how vendors proposed to position the various resources and integrate them should be enclosed along with the technical bid.

Note:

The purchaser is exempted from paying the Customs and Central Excise Duty under Govt. of India Notification No. 51/96 for customs and 10/97 for Excise Duty. Currently, the purchaser is paying 5% Basic Customs Duty, 2% Higher Educational Cess on Basic Custom Duty and 1% Secondary Educational Cess.
