ITEM NO 3. NEW PROPOSALS FOR CONSIDERATION AND APPROVAL.

1. New Annexure Building for Production Engineering Department

It is proposed to construct an Annexure building housing classrooms Laboratories and faculty rooms for Production Engineering Department with an area of 4200 sq.mts. The proposed building is a RCC framed structure (G+2) three floors with structural provision of two more floors in future. Provision for Air-conditioning, firefighting, CCTV, EPABX, conducive facilities for differently abled people, elevators are considered in the design. The Building and Works Committee considered the above project for the cost estimate of **Rs.19.97 crore** for the proposed New Laboratory Annexure for Production Engineering Department and recommend to F.C.

ITEM NO. 4 REPORTING ITEMS

i) REPORTING OF THE WORKS EXECUTED BY THE ESTATE MAINTENANCE DEPARTMENT FROM 01.12.2019 TO 31.05.2020.

ii) PROGRESS REPORT OF VARIOUS CONSTRCUTION WORKS ENTRUSTED TO CPWD

a) Chemical Engineering Annex Building:

The progress of work carried out by CPWD were noted. The building is completed. Site development works are in progress.

b) Girls Hostel-OPAL F BLOCK:

Work under progress, first and second floor brickwork, plastering work in progress. Mock room was completed only in March 2020. Progress is very slow. The original completion date was May 2019, the revised estimated completion date 28th March 2020 was also not met-with. From 25th March 2020 to 31st May 2020 work was stopped due to COVID-19 Pandemic. The work at site has resumed from 01st June 2020. The B&WC requested the CPWD to speed up the work as the Ladies hostel is absolute necessity as the girl students strength has increased. The additional 2 floors construction also has to be undertaken and the work has to be completed as early as possible for occupancy. The SE, CPWD promised to look into the matter and get the work expedited.

RESOLUTION 25/B&WC/2020/4 RESOLVED THAT the (i) works executed by the Estate Maintenance Department from 01.12.2019 to 31.05.2020 (ii) Progress of various construction works entrusted to CPWD be noted. CPWD should speed up the construction of the ladies hostel.

ITEM NO. 5 APPROVAL FOR DEMOLITION OF SNACKTERIA/ CANTEEN BUILDING

The proposal to integrate a canteen space in the ground floor of the new EEE Annex building proposed, after demolishing the existing snacketaria was discussed by the B&WC. After discussions, it was resolved to get a valuation report from CPWD for the existing snacketaria structure and present to the next B&WC with a justification report.
