ITEM NO. 1. TO CONFIRM THE MINUTES OF THE EIGHTH MEETING OF THE BUILDINGS & WORKS COMMITTEE HELD ON 19.2.2010

The Registrar had requested certain clarifications and additional information about the works already executed. The Additional Director General, CPWD had explained that the system in CPWD is very transparent and he had shown the details available with them in the meeting itself.

The Additional Director General, CPWD, Chennai had also informed that the CPWD is not charging any centage from the Institute. More over under deposit work basis, entire amount has to be deposited with the CPWD alongwith work order. NITT being a premier institution coming under MHRD, atleast 1/3 of A/A cost plus actual as per Form 65 may be made available with CPWD.

The Chairman, Buildings & Works Committee had informed that the Dean (Planning & Development) will co-ordinate with CPWD regarding completed works /works in progress for settlement of claims.
