D. DECISION AND DISCUSSION ITEMS:

ITEM NO. D 7:

TO CONSIDER AND APPROVE THE PROPOSAL TO HONOUR FACULTY AND NON - TEACHING STAFFS WHO HAVE COMPLETED 25 YEARS DISTINGUISHED SERVICE IN NIT, TIRUCHIRAPPALLI

The finance committee accepted in principle to honor faculty members and non faculty staff who have completed 25 years of distinguished service in NIT Tiruchirappalli with a memento worth of 2grams of ornamental gold.

ITEM NO. D8:

TO CONSIDER AND APPROVE THE PROPOSAL FOR PROVIDING SECRETARIAL ASSISTANCE TO HEADS OF THE DEPARTMENT, DEANS, REGISTRAR AND OTHER OFFICIALS

The Finance Committee agreed in principle the need for secretarial assistance and suggested to go for computer trainees/data entry operators. These trainees would be selected for training at NIT Tiruchirappalli in different phase of time. The period of training would be to one year, extendable by another one year depending on performance or till the time the trainee(s) attain the age of 24, whichever is earlier. At no period of time, the trainee(s) once terminated would not be reemployed either in the sanctioned project or in the general establishment of NIT Tiruchirappalli. The compensation would be Rs 7500/- per month.

ITEM NO. D9: RESTRUCTURING OF NON TEACHING STAFF POSITION AT NITT

ITEM NO. D11 OF19 FC AND ITEM NO. B12 OF 32 BOG The Member Secretary, Dean (faculty welfare), Dy.Registrar (Administration) and Associate Dean (faculty welfare) made a detailed presentation about the promotional rules for the period between 2003 to 11.06.2012 (the date of release of draft R.R).
