ITEM NO. 3 CREATION OF SIEMENS CENTRE OF EXCELLENCE IN MANUFACTURING AT NIT TIRUCHIRAPPALLI.

Mr. Bhaskar Prasad, Senior Director and Mr. Rahul Sehgal, Director, SIEMENS Industry Software (India) Pvt. Ltd. presented the proposal of starting the Centre of Excellence in Manufacturing at NIT Tiruchirappalli and the operational aspects of the Centre. The Finance Committee, after detailed discussion about the usefulness of the Centre for various stakeholders such as students and Faculty members of NIT Tiruchirappalli, neighboring Tier II & Π Educational Institutions and the Industries around, recommended to the Board of Governors, the proposal of starting the Centre in the Institute with the financial contribution of Rs. 18

Crore as 10% of the Institute share, out of a total of Rs. 180 Crore, the rest being the contribution from Siemens and its partners.

The Finance Committee further desired that the procurement by the Institute for the proposed Centre of Excellence in Manufacturing should be as per the General Financial Rules, 2017 and the CVC guidelines.
