NOTES ON ANNUAL ACCOUNTS 2006-2007

The National Institute of Technology, Tiruchirappalli is established by an act of Parliament by upgrading the erstwhile Regional Engineering Colleges during the year 2003-2004. This institute having accorded deemed university status to provide for instructions and research in Engineering, Science and Technology and is fully funded by the Government of India, Ministry of Human Resource Development. The Institute prepares its annual accounts as per the format provided by the Government of India, Ministry of Human Resource Development, New Delhi in consultation with the Comptroller and Auditor General of India and communicated to the Institute vide letters no.F.3-2/2006-IFD, dated 06.02.2006 and 01.03.2006.

The Institute was maintaining 19 separate bank accounts up to August 2006. Consequent on the restructuring of bank accounts as recommended by the Finance Committee and Board of Governors held during August 2006, the institute is maintaining the following accounts separately for each head with effect from 01.09.2006:-

The Institute prepares separate statement of Receipts and Payments Account for all the above said accounts. Consolidated statement of accounts is then prepared. The financial statements have been prepared under historical cost and on the principles of on going concern. Though the accounts were merged on 31.08.2006 Institute Fund A/C collections continued by SBI, NITT Branch till 31.03.2007. Hence the closing balance of that account also included in the Schedule.

1. SIGNIFICANT ACCOUNTING POLICIES

The institute is maintaining all the accounts on accrual basis except TEQIP (World Bank) project Account.

Hostel and mess account are consistently maintained outside the purview of Institute accounts from inception (1965) to till date as they were managed from the collection of fees separately recovered from students. It is the decision of Board of Governors to keep the accounts separately in view of the practical difficulties experienced by the institute.

2. VALUATION OF FIXED ASSETS

a) The Government of Tamil Nadu, PWD as its share for the formation of the Institute had provided the land and its value fixed by them Rs.47,09,795/- is shown in the Balance Sheet since its inception.

b) Fixed Assets are exhibited on cost basis without any depreciation. It was decided to form a committee to identify and value Buildings, Equipment & machinery, Furniture & Fixtures etc. The committee is formed to look into the matter and the matter is still under progress.

3. MODE OF INVENTORY VALUATION

The institute is booking consumables on cash basis as and when purchased and hence no closing stock for consumables is shown in the Balance Sheet.

4. FUNDS RECEIVABLE

All the grants were sanctioned and received within the financial year 2006-07 and there were cheques in transit for Rs.8.66 Crores which are duly accounted for in the accounts.

5. SUNDRY DEBTORS

A case of misappropriation of cash by the then cashier amounting to Rs.5.82 lakhs noticed during 2003-2004 and the cashier obtained the stay from High Court of Madras, Madurai Branch against taking disciplinary proceedings on him. However the case was referred to CBI for investigation and the matter is under trail in the CBI Court, Madurai. The cashier had remitted so far Rs.2.27 lakhs and the balance is due.

6. INVESTMENTS

All the investments are made on long term basis, in Banks and in approved securities as per Government of India guidelines are valued at cost.

7. PURCHASES

All capital purchases including TEQIP Library books purchased were capitalized.

8. DEPOSITS WITH CPWD

The amount of Rs.20.16 Crores was shown as deposit with CPWD as per the details available as on 31.03.2007.. The Executive Engineer, CPWD, Madurai Central Division and Executive Engineer (Electrical), CPWD, Coimbatore were already addressed for confirmation our figures.

9. The fees payable by students as shown in the Schedule No.21 of Income & Expenditure is prepared based on the Demand Collection Balance statements for each academic year.

10. RETIREMENT BENEFITS

Provision for the retirement benefits such as Gratuity, Commutation of Value of pension etc. payable to the employees retired as on 31.03.2007 are made.

11. A. CONTINGENT LIABILITIES

There is no claim pending on account of disputed items in respect of Government dues towards taxes etc. except for the back wages payable as per the award of the labour court, Tiruchirappalli in respect of an employee. As the Institute obtained a stay at the High Court of Madras, no provision was made.

B. CAPITAL COMMITMENTS

All Construction works estimated value of more than Rs.30.00 lakhs are being entrusted to CPWD on deposit work basis

12. CORPUS FUND

During the year 2006-07, an amount of Rs.4.16 Crores was contributed to this funds based on the policy guidelines framed as per the resolutions passed in the First Meeting of Finance Committee and Board of Governors of NIT.

13. CURRENT ASSETS, LOANS AND ADVANCES

The current assets, loans and advances are valued on actuals.

14. TAXATION

As per section 10 (23 C) Sub section (iii) (a & b) of Income Tax 1961, the institute being an educational institution is exempted from payment of tax and hence no provision has been made for Income Tax.

15. FOREIGN EXCHANGE TRANSACTIONS

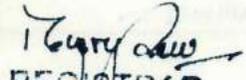

16. REMUNERATION TO AUDITORS

Approximate amount of Rs.2.50 lakhs was provided for audit fee payable for the year 2006-07 to the Accountant General, Audit I, Chennai pending receipt of claim from them.

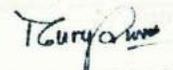

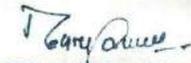

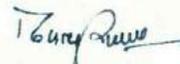
