The Chairperson of the Senate welcomed the members to the 60th meeting of the Senate and having ensured a quorum, continued with the proceedings of the meeting. She placed on record the successful completion of the AY 2022-23 and several activities including NBA visits to all the nine BTech programmes. She welcomed Prof. K. Sankaranarayanasamy back to NITT after his successful completion of his tenure as Director of NIT Puducherry.

The Chairperson has also made the following generic remarks related to the academic matters and the conduct of Senate meetings.

1. Senate related email communication shall be sent only to the Registrar, with a carbon copy (Cc) to the Dean (Academic); using "reply to all" shall be refrained.

- 2. Regulations are very important to the functioning of the institute. We arrive at them after due deliberations in the Senate, and hence let us all respect them. While operating, we may detect some gaps which shall be rectified subsequently. A constructive cycle is desirable rather than exploiting the gaps and ridiculing the entire system.
- 3. For a smooth functioning of the academics, certain matters can be readily automated so that more time is created for intellectual pursuits such as research, conferences, workshops, FDPs etc. This is easily done by synchronizing ourselves to the calendar, and stay committed throughout in all the academic activities such as conducting regular CCMs, end-semester assessments and fair grading.
- 4. Institute Day and Convocation are major events for the entire institute. Proud and proactive participation (information submission/ gathering/ verification/ processing etc., serving on committees) of all the members of the faculty make these events obviously spectacular.

Lastly, the Chairperson mentioned about the NBA visit to 5 departments during April 2023, and placed strong emphasis on the implementation of the outcome-based education (OBE).

Following the welcome address by the Chairperson, the Registrar (i/c) opened the deliberations on the agenda items.

2. UG 1st semester 2022-23 results of ICE department for July 2022 session

The results of B.Tech. 1st year, 1st semester for the July session of the AY 2022-23 as approved by the respective Performance Analysis Committees (PACs) were earlier circulated over email among the members of the Senate and subsequently published. However, for the course ENIR 11 Energy & Environment for ICE branch, there was a deviation observed from the regulation B.12.0 of the B.Tech. Regulations 2019 and hence the results were presented before the Senate, following the recommendations of the committee constituted to investigate this deviation. The Senate reiterated the importance of adhering to the regulations and stated clearly that it is only in the interest of the first semester students and the elapsed time that the results of the course are being approved in this Senate as an exception.

4. Ph.D. programme related.

During 59th Senate vide 59/SENATE/2023/3(v) it was resolved that the changes in the sitting fees/honorarium/remuneration to experts and examiners be revised. The same has been subsequently approved by the Finance committee vide **RESOLUTION 71/BoG/2022/5 with effect from FY 2023-24.**

In continuation with the above the remuneration for PhD Comprehensive examination/doctoral committee meetings where external examiners/members are asked to evaluate more than one candidate on a single day, it is now proposed to make payment @ INR 3000/- per candidate.

The Department of Electrical and Electronics Engineering conducted the meeting of Board of Studies (BoS) on 16th August 2022 and subsequently on 2nd March 2023 for its B.Tech. programme. Respective HoDs presented the details to the Senate.

6. Recognizing the department of Physical Education as an academic department, permitting it to offer Open Electives to UG and PG and also admit PhD students in the areas of Holistic sports, Health, Yoga and Fitness & Wellness etc.

Subsequent to the discussions during 59th Senate meeting, it was proposed that the Dean (Students Welfare) shall be appointed as Head-in-charge of the department. During the current meeting there was a detailed discussion on this, and based on the request of one of the members of the Senate the setting up of a Center to cater to the above curriculum has been put to vote. Of 79 votes that were polled, 28 were in favour and 48 were against the proposal, and 3 votes were neutral. Another member of the Senate pointed out that appointing a Dean as Head-in-charge may not be permitted.
