ADMISSION NOTIFICATION FOR M. A. IN ENGLISH (2024 – 2025)

GENERAL:

1. National Institute of Technology, Tiruchirappalli invites applications from eligible Indian citizens for admission into M. A. programme offered in the Department of Humanities and Social Sciences for the academic year 2024-2025. Degree requirements for admission is given below:

Programme offered	Eligible Bachelor's Degree
M.A. English	B.A. in English literature / ELT / Linguistics from any recognized university / college.

- a. Candidates who have already passed their qualifying degree examination or who have appeared / are appearing for the final semester/year examination in 2024 are also eligible to apply. Those candidates who have appeared for final semester / year examination, provisional admission is permitted provided their final marks are made available on or before 30th August 2024.
2. **Admission is based on NTA CUET-PG 2024 score and eligibility criteria set by NIT-T.**
 3. **There is no stipend for the candidates admitted to M.A. programme.**

ELIGIBILITY FOR ADMISSION TO M.A. PROGRAMME:

1. Candidates seeking admission to M.A. degree programme shall have First class (60% or above of aggregate marks or 6.5 CGPA) in B.A. in English Literature / ELT / Linguistics from any recognized university / college.
2. SC / ST / PwD candidates seeking admission to M.A. degree programme shall have 55% or above (6.0 CGPA) in B.A. in English literature / ELT / linguistics from any recognized university / college.
3. Candidates appearing in the final year of Bachelor degree programme may also apply. Provisional admission is permitted for such candidates. Any candidate admitted provisionally shall produce the provisional / degree certificate and all mark lists in original on or before 30th August 2024. Else, their admission shall stand cancelled. For such candidates refund will be made as per the institute norms.
4. Conversion from CGPA to percentage or vice versa given by individual institute will not be considered / allowed.

Reservation: Government of India reservation policy will be followed for GEN-EWS, OBC-NCL, SC, ST and Persons with Disability (PwD).

In case of GEN-EWS, OBC-NCL category, the certificate must be issued on or after 1st April 2024 and should be submitted in prescribed format.

APPLICATION PROCEDURE:

Admission is based on NTA CUET-PG 2024.

1. Applicants must apply through the online portal <https://nittadm.samarth.edu> only.
2. Candidates should apply online and upload the requisite documents / certificates. Online portal will close on 16th June 2024.

3. Applicants MUST upload the following scanned documents while submitting the Application.
- i. Mark sheet of Class X.
 - ii. Mark sheet of Class XII.
 - iii. NTA CUET (PG) score card.
 - iv. Photo id proof (Aadhaar) as per the Govt. of India norms.
 - v. Grade / Mark sheets of qualifying examination for all semesters.
 - vi. Degree / Provisional certificate. If the result of qualifying degree is awaited, certificate of course completion from the institute / university last studied must be provided.
 - vii. Transfer Certificate issued from the institute last studied/attended.
 - viii. Migration Certificate, for applicants other than Tamil Nadu candidates.
 - ix. Certificate of category (GEN-EWS, OBC-NCL, SC, ST). In case of GEN-EWS, OBC-NCL category, the certificate must be issued on or after 1st April 2024. (if applicable).
 - x. Certificate for Persons with Disabilities (PwD) issued by Medical Board notified under PwD Act. (if applicable).

APPLICATION FEES:

The application fee is Rs.500/- for GEN / GEN-EWS / OBC-NCL and Rs.200/- for SC / ST / PwD candidates. The application fee is non-refundable.
