Remuneration:

The Honorarium payable to the Visiting consultant would be fixed, according to their specialization shown in the above tabulation i.e. Specialist (Sl.no.1-7)- Rs.2000 per hour, Dentist – Rs. 1500 per hour, Ayurveda & Homeopathy – Rs.1250 per hour, Physiotherapist- Rs. 500 per hour, Cardiologist-Rs.2000 per hour.

In addition, the Visiting Consultant is eligible for the Conveyance Charges of Rs. 500 per visit.

Terms and Conditions:

1. The engagement of Visiting consultants will be purely temporary and will not confer any right to them to claim the status of a regular employee of the institute.
2. The Visiting Consultant will not be entitled for any other Allowance or Benefits other than those indicated above.
3. The Visiting Consultants will abide by the Institution Rules and Regulations governing their engagement.
4. The Visiting Consultants will safeguard the security and confidentiality of all official matters and secrecy of information coming to their knowledge.
5. The Honorarium is fixed and there is no scope of increased Honorarium.

Termination of Engagement:

The Engagement of the Visiting Consultant will stand automatically terminated on completion of prescribed tenure as specified in the Offer of Engagement. The Engagement can be terminated even earlier, with 01-month Notice in writing either side.

Selection Criteria: (Certificate Verification and Walk-In Interview)

General Instructions: The applicants should go through all the instructions carefully and ensure that they fulfil all eligibility conditions. Their admission to all stages of the selection will be purely provisional subject to satisfying the eligibility conditions.

1. Candidates should carefully fill up all the details required in the application form including age, Education Qualification, details of valid Community / PwD Certificates etc., as no correspondence regarding the change of details will be entertained after the last date for applying. If any of the claim by the candidate is found to be incorrect, it will lead to the rejection of the candidature.


2. The prescribed essential qualifications / experience indicated are bare minimum and mere possession of the same will not entitle the candidate to be called for Certificate Verification / Interview.
3. Any experience gained after the minimum qualifying degree will only be taken into consideration.
4. The Institute reserves the right to restrict the number of candidates called for interview to a reasonable limit on the basis of qualifications, level of relevance of experience higher than the minimum prescribed in the advertisement and other academic achievements.
5. The Institute has the right to decide the mode of screening and testing the applicant for short listing and selection.
6. The number of vacancies indicated in the notification is tentative. The Institute reserves the right not to fill any or all posts advertised and to reject any or all applications without assigning any reason.
7. Candidates must produce original documents at the time of appearing for Certificate Verification / Interview / whenever the same is called for.
8. Applications filled incomplete / not on prescribed format / without relevant documents will not be considered.
9. The provisionally shortlisted candidates should attend the interview in person on the specified date.
10. Any dispute with regard to the selection process will be subject to court / tribunal having jurisdiction over Tiruchirappalli.
11. Canvassing in any form/ bringing in any influence, political or otherwise will be treated as a disqualification for the post. Interim enquiries will not be entertained. If it is found at any stage that any information given in the application is incorrect / false, the candidature / appointment is liable to be cancelled / terminated.
12. The age limit, if any shall be as on the date of Walk-In Interview.
