- The admission of candidates to Stage III (Main Test) is purely provisional and it is subject to verification and acceptance of the claim in their online applications towards Age, Age relaxation, Educational Qualification, Communal Category, PwD, Ex-serviceman etc., through original documents.
- 3. The admission of the shortlisted candidates is purely provisional subject to the decision of the Institute and subject to the outcome or final orders in any of the pending writs of the Hon'ble High Court of Judicature at Madras Madurai Bench.
- 4. Candidates who have been admitted provisionally to the Main Test are hereby advised to attend the Main Test with the soft copy / printout of Admit card for Stage III test. The shortlisted candidates may download the Admit card from the recruitment portal.
- Travelling and other expenses would be borne by the candidate and no travelling expenses such as TA/DA, accommodation etc. will be admissible for appearing on the recruitment process.
- 6. Change of venue will not be permitted under any circumstances.
- 7. Candidates have to make their own arrangements for travel to the examination centre/stay for the recruitment process. They should strictly adhere to the COVID-19 Standard Operating Procedure (SoP) issued from time to time.
