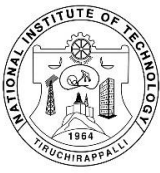

The PwBD candidates, who opt to bring his/her own-scribe for assistance, shall write to recruitcell@nitt.edu on or before 01.06.2026, 05.00pm along with the personal, educational details, scanned copy of govt-issued ID of the scribe. The scribe should be in accordance with the guidelines issued by Government of India.
