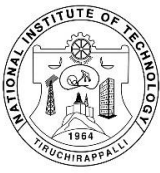

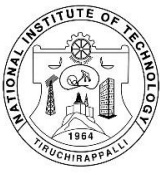

1. The Admission to the Selection Process is subject to the production of original documents in support of educational and experience qualifications prescribed for the post and for the information furnished by the applicants in their application.

The Original Community/Caste Certificate (ST/ST/OBC/EWS) and other original certificates claiming age relaxations (PwBD, Ex-Serviceman, Departmental Candidates) should be in the prescribed format duly signed by the authorized authorities and should be valid as on the date of verification of documents, failing which, their candidature will not be considered for further selection process.

The scribe should be in accordance with the guidelines issued by Government of India.
