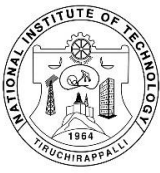

The Admission to the Selection Process is subject to the production of original documents in support of educational and experience qualifications prescribed for the post and for the information furnished by the applicants in their application.
2. **The Candidates are required to ensure and satisfy themselves on meeting the essential educational and experience qualification prescribed for the post prior to appearing for the selection.** If original documents in support of qualifications, caste/community certificates and for other information furnished in the application is not produced at the time of document verification, their candidature will be summarily rejected at any point of time.
3. No Objection Certificate (NOC) is mandatory for the persons serving in Government / Semi-Government / Autonomous Bodies / Statutory Bodies / PSUs / PSBs. Such serving persons should furnish a No Objection Certificate (NOC) from the designated authority of the organization they are serving, at the time of verification, failing which their candidature will be summarily rejected and will not be considered for further selection process.
4. The Original Community/Caste Certificate (ST/ST/OBC/EWS) and other original certificates claiming age relaxations (PwBD, Ex-Serviceman, Departmental Candidates) should be in the prescribed format duly signed by the authorized authorities and should be valid as on the date of verification of documents, failing which, their candidature will not be considered for further selection process.
5. The PwBD candidates, who opt to bring his/her own-scribe for assistance, shall write to recruitcell@nitt.edu on or before 23.06.2026, 05.00pm along with the personal, educational details, scanned copy of govt-issued ID of the scribe. The scribe should be in accordance with the guidelines issued by Government of India.

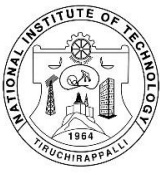
