1.	The quotation must be in the format furnished by NIT Tiruchirappalli and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not, the quotation will not be considered. Quotation written in pencil and incomplete will be rejected.
2.	Scope of work: The vendor should install all the required equipment for laundry service like IoT based washing machines (10kg), and other software and hardware requirements and other requisites for the functioning of Laundry facilities on his/her own cost based on revenue sharing basis. The scope includes 1. The Laundry needs to be opened on all the days, including holidays and the Laundry timings are 24/7.
	Note: - The complete work flow of the Laundry services and the communication matrix of firm are to be clearly mentioned in the separate sheet and same should be submitted along with this tender. 2. The vendor should enable digital payment facilities through android based App.
3.	Service provider should be the Commercial Laundry equipment firm.
4.	a) Bidder should have experience of successful execution of similar project in any educational Institutes / Universities for the past three year from tender due date. Bidder should have supplied minimum of 30 or more units of similar type of washing machines to at least one reputed Institutional hostels. Proof to be submitted.
	b) The average annual turn over of the bidder in the preceding three financial years shall be minimum 20 lakhs and above. Audited balance sheet and P/L accounts to be submitted as a proof.
5.	The service provider shall adhere rules and regulations of state/central Government.
6.	It is responsibility of the service provider for any damage to machines, safety and security.
7.	The washing machine should be Industrial type machines and should be operated 24 x 7.
8.	Washing machine should be operated by IOT based system. Washing charges collection is the scope of the service provider. Hostel authorities shall not take any responsibility.
9.	All washing machines should be brand new and insured. All Safety and security measures should be followed and complied by the service provider.
10.	Based on demand, the supplier should deploy more number of machines.
11.	If any machine fails during the contract period within 48 hrs new machines should be replaced. If not replaced, a penalty of Rs.1000/- will be levied per day.

12.	Service person should be available within 24 hrs if any service is required. Failing which a penalty of Rs.500/- will be levied.
13.	Execution / deployment of similar work or service to educational Institutes/Govt. Agencies/ Semi Govt./ Autonomous Organizations/ PSUs/Reputed Limited Companies comparable to NIT Trichy is must. Proof to be attached.
14.	Institute shall provide space, water and electrical connections. Subletting of the contract shall not be permitted. Vendor shall provide user manual for educating the users for operating the washing machine.
15.	Rate should be quoted for per wash rate. 15% of the each per wash quoted rate shall be paid by the service provider as rent, water and electrical charges to the NITT hostel administration.
16.	Service provider must pay the 15% of the revenue charges to the hostel administration on 10 th of each month. The report on utilization of the machines should be shared by the service provider with the Hostel administration. a) The Institute is not responsible for any damage or loss towards the operation of the equipment deployed at the Institute Hostels and it is sole responsibility of the service provider. b) The service provider shall ensure all the safety and security measures for operating the laundry service at their cost.
17.	Rate quoted should be including taxes. Percentage of taxes to be charged must be clearly stated.
18.	The Initial contract period will be for one year, and extendable for another two years based upon the satisfactory performance/service on yearly review basis as approved by the competent authority on the same terms and conditions. However, the Institute has the rights to terminate the contract at any time during the period of contract if the performance/service is not found satisfactory with prior notice.
19.	The quoted price is fixed for entire contract period.
20.	Service provider should submit detailed report on execution, requirements from the hostel administration and any other conditions along with the tender.

- d. National Institute of Technology, Tiruchirappalli, prior to the expiration of the quotation validity period, will notify the bidder whose bid is accepted for the award of contract. The terms of accepted offer shall be incorporated in the purchase order.
